## BASIS OF ACCOUNTING

The accompanying financial statements have been prepared on the cash receipts and disbursements basis of accounting. Under that basis, the only assets recognized are cash and cash equivalents and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements, and non-cash transactions are not recognized. The cash basis differs

from generally accepted accounting principles primarily because no accruals are recognized in the financial statements. In particular, outstanding dues unpaid at the reporting date are not shown in the financial statements.

#### CURRENCY TRANSLATION

The organization keeps accounts in Europe (in Euro) and in the U.S.A. (in U.S. Dollars). The cash flows are shown in separate columns. The reporting currency is U.S. Dollars. Euros are translated to U.S. Dollars at the closing rate of 1.32 in 2006 (1.18 in 2005; 1.36 in 2004). The exchange rate difference in the fund balance is the difference in the closing rates between the beginning and end of the year applied to the beginning balance of the Euro account.

#### **NOTES TO SPECIFIC ITEMS**

#### MEMBERSHIP DUES

As of December 31, 2006 IAAER had 906 individual members, 5 university members, which is a new category of membership, and 54 institutional members (December 31, 2005: 763 individual and 46 institutional members; December 31, 2004: 708 individual and 41 institutional members). Membership dues in 2006 (2005 / 2004) consisted of 409 (14 / 58) three-year individual membership dues at \$45 each, 4 (43 / some 300) special one-year membership dues, 5 (0 / 0) three-year university membership dues at \$350 each, and 33 (35 / 29) institutional membership dues at \$350 each. It is the policy of the Executive Committee to waive the membership fee for institutional members in cases where it is difficult or impossible to obtain or transfer funds.

## **GRANTS**

In 2006 the organization received grants in the amount of \$247,500 (2005: \$57,500) from KPMG to sponsor academic research programs on Reporting Financial Performance (RFP) and on Defining, Recognizing and Measuring Liabilities (DRML). It used \$73,585 (2005: \$49,629) for research grants and to support workshops in which research results were discussed. The rest of these funds are restricted for the research projects.

## INVESTMENT OF CASH

In 2006 the organization invested cash not required for current operations in two Certificates of Deposit consisting of \$100,000 with maturity date November 2007 (interest rate 4.8 % per year) and \$50,000 with August 2007 (interest rate 4.8% per year) (2005: \$25,000 – maturity date August 2007 and interest rate of 3.2% per year; 2004: none).

#### OTHER COMMITMENTS

The organization is committed to support the 10<sup>th</sup> World Congress of Accounting Educators 2006 with up to \$3,600 (rounded) (2005: \$10,000), the Globalization Roundtable held in Istanbul 2006 with up to \$5,000 (2005: \$5,000), and the publication of papers presented at the World Congress with up to \$5,000 (2005: \$5,000). In 2004 the organization was committed to support the 4<sup>th</sup> Biennial International Accounting Conference 2004 with the amount of up to \$5,000.
