President's Letter

Dear IAAER Members,

In my first President's letter, I would like to extend my sincere thanks to the Nominations Committee, Executive Committee, and entire membership of IAAER for providing me with the opportunity to serve as President of our international organization. Your confidence and trust are greatly appreciated, and I pledge to do my best to serve IAAER and our membership.

Our new IAAER Executive Committee met for the first time at our World Congress in Istanbul. In partnership with our new Advisory Board and our Institutional Members, we are committed to continuing and growing the programs and activities for which IAAER is now globally recognized. These include our World Congress and joint conferences with Institutional Members. It will be a tremendous challenge to match the excellent World Congress coordinated by Executive Committee member Recep Pekdimer and his team in Istanbul in November 2006, but we will do our best to maintain the high standard set by past conferences. At our April 2007 meeting in Lisbon, the Executive Committee will be discussing possible locations for our 2010 World Congress. I hope to announce the location in the July issue of COSMOS.

During 2007, I hope many of you will join us September 12-13 in Paris and September 26-28 in Mexico City for conferences held in collaboration with EUFIN and ASCAM, respectively. IAAER will also coordinate an education workshop and a plenary session at the 2nd AMIS International Accounting Conference; the meeting will be held June 21-22 in Bucharest. In December 2007, IAAER will be participating in the ICAEW's Better Markets Conference focusing on Accounting for Intangibles. IAAER will also hold joint meetings in 2008 with the AAA International Accounting Section in San Diego (February) and AAFANZ in Sydney (July). The call for papers and information on these 2007 and 2008 events are included in this issue of COSMOS and on the IAAER website. Niamh Brennan, our new Vice President- International Conferences and I welcome your suggestions for joint events and other collaborations for 2009 and beyond. We are particularly interested in partnering with IAAER Institutional Members on conferences and workshops.

I am very pleased to announce that the founding members of IAAER's new Advisory Group will include Past Presidents Sid Gray and Bel Needles. Sid and Bel will be joined by former Executive Committee members Mike Walsh of the ACCA, Tatiana Krylova of UNCTAD, and Kazuo Hiramatsu of the Japanese Accounting Association. We are also delighted that Jim Sylph will represent IFAC on the advisory group. With Gary Sundem assuming the role of IAAER Vice President- Education and accordingly representing IAAER as an observer on the IFAC Education Committee, I am confident that IAAER and IFAC will identify several endeavors that we can participate in jointly during the future to further our common goals of promoting and strengthening accounting education globally.

In addition to strengthening our ties with IFAC, the **IAAER** Executive Committee continues to work with the IASB. Most notable among these efforts is our Research Grant Program generously funded by KPMG. These grants support academic research designed to inform the IASB in their decision process. We completed an extremely successful series of research projects on Reporting Financial Performance at November World Congress and will soon be announcing the recipients of



five grants for our Defining Liabilities program. IAAER is very grateful to Tim Bell of KPMG, Mary Barth of the IASB, and Katherine Schipper of Duke University for their tremendous support of this project and service on the Program Advisory Committee. I would also like to thank the ICAEW and AAA for agreeing to host deliverables for our Defining Liabilities program in London in September 2007 and in Orange Country, California in August 2008, respectively. I would also like to thank the IASB for considering IAAER's request on behalf of our membership and offering an academic discount for certain forthcoming conferences. This issue of COSMOS includes an announcement for an IASB workshop that offers a 45% academic discount and includes a workshop designed especially for accounting researchers and educators.

In closing, I would also like to highlight our new IAAER university membership. The membership entitles all members of a university's faculty to a three year IAAER membership. Additionally, university members will be acknowledged on our website. A copy of the membership form is included in this issue of COSMOS and on the IAAER website. I strongly recommend academic members of IAAER to encourage their university to take advantage of this offer.

Minutes of Joint Executive Committee / Executive Council Meeting

August 8, 2006 Omni Shoreham Hotel Washington DC, USA

The Executive Committee and Executive Council meeting was called to order by President Serge Evraert at 10:00 a.m. on August 8, 2006, in the Forum Room of the Omni Shoreham Hotel in Washington DC, USA. In attendance were Bhabatosh Banerjee, Ilias G Basioudis, Serge Evraert, Steven Firer, Jim Gaa, Kazuo Hiramatsu, Janet Morrill, Bel Needles, Lee Radebaugh, Salvador Ruiz de Chavez, Donna Street, Gary Sundem, Shyam Sunder, Alfred Wagenhofer, and Richard Wilson.

President Serge Evraert welcomed everyone. Because there were several new attendees, Serge asked everyone to introduce himself or herself. He then quickly summarized a productive year for IAAER. He described the preparation for the upcoming World Congress in Istanbul and pointed out that IAAER has five events scheduled in the next year. He thanked the Executive Committee and others for all the work that has gone into successfully carrying out all the IAAER activities.

Next, the minutes from the Dublin meeting were approved.

Alfred Wagenhofer presented the financial report for the first half of 2006. The net cash inflow was approximately \$21,000. However, he reminded members that the IAAER is on a cash basis of accounting, and much of the cash inflow is restricted to funding particular projects, primarily the KPMG-sponsored research projects.

Gary Sundem next presented a report on membership. The membership of those who joined IAAER at the World Congress in 2002 expired at the beginning of this year. Renewal notices were sent out, and 141 renewals and new memberships have been received so far this year. In addition 27 renewals of Institutional Memberships have been received; 11 more are still outstanding. Nine Institutional Members have their dues waived through a grant from KPMG.

Bel Needles reported on plans for the World Congress in Istanbul in the absence of Recep Pekdemir. Plans are progressing well with the 3 plenary sessions and the panel sessions nearly set. Seventy main papers and nearly 100 research forum papers have been accepted. However, the number of registrations is lagging, as are sponsorships. The conference committee was encouraged to seek additional sponsorships. Several members thought that persons who planned to attend were not aware of the cutoff for early registrations fees. The EC voted to extend the deadline for early registration at the \$445 fee to September 15. It also voted to commit an additional \$10,000 to the conference if needed, bringing the total IAAER commitment to \$20,000, \$15,000 for the conference and \$5,000 for the roundtable. Concern was raised that attendance may suffer because of fear of the turmoil in the Middle East. However, there is nothing that we can do about that. Finally, Bel handed out copies of the program for the IAAER Globalization Roundtable on the topic of "Benchmarking International Education Standards," and a summary of the status of the 5 World Congress panels.

Salvador Ruiz de Chavez gave a brief report on the joint conference in Mexico City, indicating that the dates were changed to 27-29 September 2007 to avoid conflicting with presentation of the IAAER research reports in conjunction with the IASB meeting earlier in September. Donna Street reported that the first set of deliverables for the "Defining, Recognizing and Measuring

Liabilities" project will be in London in September 14, 2007 immediately following a conference that IAAER will co-sponsor with the BAA International Special Interest Section and Eufin in Paris (September 12-13).

Three other conferences are scheduled in the next 2 years. In December 2007 IAAER is collaborating with the ICAEW for their Better Markets Conference on "Intangibles" that will be held in London. Donna Street, Alfred Wagenhofer, and Martin Hoogendoorn are on the planning committee representing IAAER. Donna reported the IAAER Executive Committee will be invited to the 2006 ICAEW conference on "Measurement." In February 2008 there will be a joint conference with the International Section of AAA, probably in San Diego. Donna is working with Jenice Prather-Kinsey on this conference. Finally, IAAER will collaborate with the Accounting Association of Australia and New Zealand on part of their Annual Meeting in Sydney in July 2008.

Donna Street reported on the two research programs sponsored by KPMG. Round one, "Reporting Financial Performance," is nearly complete, with presentations by 4 of the teams at the AAA meetings and final presentations by all 5 at the World Congress. Round two, "Defining, Recognizing and Measuring Liabilities," has been approved by KPMG and the call for proposals is out. Proposals are due in December and winners will be announced in January. Deliverables will begin with a workshop in September 2007 that will be hosted by the ICAEW and will include presentations at the AAA Annual Meeting in 2008 and at a conference with standard setters sometime to be determined.

Donna also reported that she and Gunther Gebhardt will represent IAAER as co-editors of a JIFMA Institutional Perspectives Section. In the past Donna and Ann Johns shared this duty. Donna is setting up a committee to examine the "fast track" option for papers submitted to IAAER conferences.

Bel Needles reported on the proposed changes in the IAAER Constitution. Some were "house keeping" issues, and the main substantive issues were:

- 1. Change "Vice-President, World Congresses" to "Vice-President, International Conferences,"
- 2. Change "Vice-President, Publications" to "Vice-President, Communications,"
- 3. Change the number of Vice-Presidents at Large to 8,
- 4. Eliminate the Executive Council, and
- 5. Add a Board of Advisors consisting of up to 5 past presidents and up to 7 additional members from accounting education and practice.

These were previously approved by the EC, and they are to be voted on at the General Business Meeting later in the afternoon.

Next on the agenda was a report from the Nominating Committee. Bel Needles reported that the slate is complete, and the election will take place at the General Business Meeting at the World Congress. Nominees for officers of the association are:

Bel also reported that the Nominating Committee recommended that the Founders' Award be presented to Sid Gray. This motion was approved unanimously.

Lee Radebaugh reported that COSMOS will come out on time in December and asked anyone with announcements to be included to let him know soon. He would like to be able to include more news from the Institutional Members.

Under other business, Shyam Sunder reported on the Global Accounting Archives Project by the AAA, EAA, and others to create an Internet portal to link archived projects around the world. He thought there might be a role for IAAER in this project.

Bel Needles reported on two additional issues. He has the collected papers of the IAAER in boxes. He will look into how to digitize and archive these important records. Also, he attended the International Accounting Education Standards Board meeting in Santiago, Chile in July. He briefly explained the Board's publications and indicated that there may be a significant role for the IAAER in research related to the Board's agenda.

Serge Evraert adjourned the meeting at 12:10.

Minutes of General Business Meeting

August 8, 2006 Omni Shoreham Hotel Washington DC, USA

The General Business meeting was called to order by President Serge Evraert at 5:00 p.m. on August 8, 2005, in the Cabinet Room of the Omni Shoreham Hotel, Washington DC, USA.

President Serge Evraert welcomed everyone and quickly summarized a productive year for IAAER. He described the preparation for the upcoming World Congress in Istanbul and pointed out that IAAER has 5 events scheduled in the next year. He thanked the Executive Committee and others for all the work that has gone into successfully carrying out all the IAAER activities.

The minutes from the San Francisco general business meeting in August 2005 were approved.

Alfred Wagenhofer presented the financial report for the first half of 2006. The net cash inflow was approximately \$21,000. Some of this is for funding specific projects and is not available for general expenses.

VP-Administration Gary Sundem next presented a report on membership. So far this year 141 renewals and new memberships have been received. In addition 27 renewals of Institutional Memberships have been received.

Bel Needles reported on plans for the World Congress in Istanbul in the absence of Recep Pekdemir. Plans are progressing well with the 3 plenary sessions and the panel sessions nearly set. Seventy main papers and nearly 100 research forum papers have been accepted. He also announced that the date for registration at \$445 (without a late penalty) has been extended to September 15.

Donna Street reported on future conferences in the absence of Agnes Cheng. Conferences in 2007 include one in Mexico in September, a workshop hosted by the ICAEW as part of the second KPMG-sponsored research project in London in September (IAAER will collaborate with the BAA International Accounting Section Group and Eufin on a conference to be held in Paris immediately preceding the workshop), and a joint conference with ICAEW in December. In 2008 there will be conferences with the International Section of the AAA (probably in San Diego in February) and with the Accounting and Finance Association of Australia and New Zealand in Sydney in July.

Donna also reported on the research agenda. There was a session on the KPMG-sponsored project on "Reporting Financial Performance" that afternoon at the AAA Annual Meeting, and the final presentation of research results will be at the World Congress in November. KPMG has agreed to sponsor a second round of research projects, this time on "Defining, Recognizing and Measuring Liabilities," with up to 5 more projects to be funded. The submission deadline for proposals is December, winners will be announced in January, and the first set of deliverables will be in September 2007. Results will be presented in the London workshop noted above and at the 2008 AAA Annual Meeting and subsequently to standard setters at a meeting to be determined.

Bel Needles next presented for vote some changes in the IAAER constitution. Some were "house keeping" issues, and the main substantive issues were:

- 1. Change "Vice-President, World Congresses" to "Vice-President, International Conferences,"
- 2. Change "Vice-President, Publications" to "Vice-President, Communications,"
- 3. Change the number of Vice-Presidents at Large to 8,
- 4. Eliminate the Executive Council, and
- 5. Add a Board of Advisors consisting of up to 5 past presidents and up to 7 additional members from accounting education and practice.

After Bel gave further justification for the changes, the membership approved them unanimously.

Minutes of the Executive Committee

November 8, 2006 Istanbul University Faculty Club Istanbul, Turkey

The Executive Committee meeting was called to order by President Serge Evraert at 2:10 p.m. on November 8, 2006, in the Faculty Club of Istanbul University. Members present were Agnes Chang, Serge Evraert, Guiseppe Galassi, Simon Ho, Bryan Howieson, Bel Needles, Lee Radebaugh, Salvador Ruiz de Chavez, Donna Street, Gary Sundem, Shyam Sunder, Alfred Wagenhofer, and Richard Wilson. Incoming Executive Committee members present were John Ahern, Guenther Gebhardt, and Martin Hoogendoorn. Hua Wang of Jinan University in China attended as a guest. Yakup Selvi hosted the meeting on behalf of Recep Pekdemir.

President Serge Evraert welcomed everyone. Because there were several new attendees, everyone introduced himself or herself. Serge next expressed pride in the team of leadership at IAAER and summarized their accomplishments over the last four years in three categories: 1) Modernization – for example, improved Web site, member database on the Web, and taking over administration from EAISM, 2) Presence – expanded number of conferences, several with joint sponsors, and vastly increased research activities, especially the partnership with KPMG on one completed and one new project, and 3) Network – journals (especially adding Accounting Education in 2005), increased relationship with IFAC and the IAESB, growing number of Institutional Members, the new University Membership, and the Roundtables at Bordeaux and Istanbul. Serge also stated that he had hoped to accomplish more on ethics and corporate governance and corporate social responsibility, but time did not allow for as much progress as he would have liked.

Next, the minutes from the Washington DC meeting were approved.

Gary Sundem presented a brief report on his activities. The administration continues to go well. There was a discussion on the new University Membership, specifically if the fee should be proportional to the number of faculty members at the university. It was decided to leave the fee at \$350 for three years regardless of the number of faculty.

Bel Needles reported on the World Congress in the absence of Recep Pekdemir. He complimented Recep for the organization of the Congress and Donna for coordinating the review of the papers. Bel put together the 12 panels, and he thanked the Executive Committee for their help on this task. Recep was responsible for the plenary sessions and entertainment. Bel encouraged all EC members to attend the Town Hall session scheduled for 2:00 on Friday. It was confirmed that "best paper" awards for the best research and best education paper will be presented, and a plaque will be sent later by Gary.

Upcoming conferences include the joint conference in Mexico City, 27-29 September 2007 (for which Salvador will bring fliers), a joint conference with AFAANZ in early July 2008 (Bryan Howieson said that plans are progressing well), and a joint conference with the AAA International Section in February 2008. It was mentioned that organizers should plan to make "best paper" awards at these conferences. Another conference is the invitation-only conference with ICAEW in December 2008. Martin, Alfred, and Donna are on the planning committee. Donna Street reported that the first set of deliverables for the "Defining, Recognizing and Measuring Liabilities" project will be in London in September 2007 immediately following a BAA conference in Paris.

The need for a conference "check list" was discussed, especially for the World Congresses and other conferences for which IAAER is a primary sponsor. It was agreed that such a check list would be helpful.

Donna Street reported on the two research programs sponsored by KPMG. Round one, "Reporting Financial Performance," will be completed by the final presentations by all 5 teams at 8:00 Saturday morning. Requests for proposals for round two, "Defining, Recognizing and Measuring Liabilities," have been distributed. Proposals are due in December and winners will be announced in January.

The desirability of also sponsoring some educational research to support the IFAC's International Accounting Education Standards Board was discussed. Gary Sundem will prepare a plan to develop possible topics for which funding can be sought.

Lee Radebaugh distributed copies of COSMOS. He will revise the Web site to recognize the replacement of the Executive Council by the Advisory Board.

Dick Wilson reported on Accounting Education: An International Journal. Serge edited the December 2006 issues based on the Bordeaux conference. Papers for the World Congress are in process, with revisions due by the end of 2006. He and other education journal editors are collaborating on a piece promoting the status of accounting education research.

A brief discussion ensued on whether we should disseminate information from universities with open positions. It was decided not to do so, but to refer such requests to SSRN.

Alfred Wagenhofer presented a brief financial report, indicating that the main cash outflows were for the first KPMG research project, and most inflows are for advance funding of KPMG's second project. The advance payments are being invested to earn interest. It was also decided to include full financial statements only in the July issue of COSMOS.

Serge Evraert adjourned the meeting at 4:30.

Minutes of General Business Meeting

November 9, 2006 Istanbul Convention and Exhibition Center Istanbul, Turkey

The General Business meeting was called to order by President Serge Evraert at 5:45 p.m. on November 9, 2005, in the Marmara Room of the Istanbul Convention and Exhibition Center.

President Serge Evraert welcomed everyone and expressed thanks to the Executive Committee for their efforts over the last 4 years. He expressed best wishes to the new Executive Committee in carrying forward IAAER activities. He then summarized some of the statistics for the World Congress – congratulating and thanking the organizers for making the Congress successful.

The minutes from the Washington DC general business meeting in August 2006 were approved.

Alfred Wagenhofer reported that the 2005 audited financial statements are in the July issue of COSMOS. Most of the financial activity in 2006 has related to the KPMG grants, with most outflows representing expenses for the first round of grants. We have also received the full amount for the second round of grants and it is invested in CDs until needed for payments.

Recep Pekdemir reported that registrations for the World Congress have topped 500, and there were more than 150 papers presented. He thanked everyone for coming to the Congress.

Agnes Cheng reported on future conferences. Conferences in 2007 include one in Mexico in September, a workshop as part of the second KPMG-sponsored research project in Paris/London in September, and a joint conference with ICAEW in December. In 2008 there will be conferences with the International Section of the AAA in San Diego in February and with the Accounting and Finance Association of Australia and New Zealand in Sydney in July.

Donna Street reported on the research agenda. The final results of the five KPMG-sponsored projects on "Reporting Financial Performance" will be presented at 8:00 Saturday morning, following a breakfast sponsored also by KPMG. KPMG is also sponsoring a second round of research projects, this time on "Defining, Recognizing and Measuring Liabilities," with up to 5 more projects to be funded. The submission deadline for proposals is December 15.

Bel Needles then presented the report of the Nominating Committee. First he thanked the members of the Nominating Committee, and then he presented the following nominees for a vote of the membership:

Minutes of General Business Meeting

April 25, 2007 Lisbon Congress Center Lisbon, Portugal

The IAAER Executive Committee meeting was called to order by President Donna Street at 8:00am on April 25, 2007 in the Lisbon Congress Center in Lisbon Portugal.

Members present were John Ahern, Serge Evraert, Guiseppe Galassi, Gunther Gebhardt, Martin Hoogendoorn, Bryan Howieson, Recep Pekdemir, Lee Radebaugh, Donna Street, Gary Sundem, Shyam Sunder, Marianne van Staden, Alfred Wagenhofer, and Richard Wilson. Clare Minchington and Caroline Oades joined the meeting for the discussion of the proposed ACCA-sponsored research projects. Jenny Stewart joined to discuss the forthcoming co-sponsored meeting with AFAANZ.

President Donna Street welcomed everyone. Attendees then introduced themselves. A new member of the Executive Committee is Marianne van Staden of the University of South Africa. Marianne is taking the place of Steven Firer who resigned as President of the Southern African Accounting Association.

Donna Street noted that representatives of the ACCA would join us toward the end of the meeting to discuss the possibility of collaborating with IAAER on several projects associated with research and education.

Next, the minutes from the Executive Committee meeting in Istanbul, Turkey in November, 2006 were approved.

The President's report then followed:

Donna Street discussed the ongoing activities surrounding the KPMG / IAAER research grants. Five teams have been selected to participate in "Round 2." Each project addresses an issue associated with the IASB project on liability and equity distinction. The first deliverable will be hosted by the ICAEW in September 2007 in London. Tim Bell of KPMG, Mary Barth of the IASB, and Katherine Schipper of Duke University will continue as members of the Program Advisory Committee along with Street.

- The KPMG Diversity grants are designed to cover the IAAER membership dues of institutional members who might not be able to afford to pay the dues and to support travel grants to IAAER conferences. KPMG has a June 30 year end and it is important to submit the request for reimbursement before that time. John Ahern and Bel Needles will follow up on billing KPMG.
- Donna Street then reported on collaborative efforts with ACCA. Gunther Gebhardt has been appointed to ACCA's Research Committee as an IAAER representative. ACCA is interested in supporting an accounting education research competition that would be modeled after the KPMG grant program. The grant program would support the agenda of IFAC's International Accounting Education Standards Board (IAESB). ACCA is also interested in co-sponsoring a research conference with IAAER in London.

- Next President Street discussed the JIFMA Institutional Perspectives section. Donna is the Co-editor of the Section with Gunther Gebhardt and needs assistance getting people to submit papers.
 - She asked Executive Committee (EC) members for their ideas regarding future topics. Alfred Wagenofer suggested current topics which might spur further research and Martin Hoogendoorn agreed that he could provide some suggestions.
 - Donna has asked John Ahern to reserve a room all day at the upcoming American Accounting Association meeting to be held in Chicago August 5-8, 2007. The room could be used for not only for the IAAER Executive Committee meeting but for sub- groups of the Committee to meet.
 - Bel Needles will host a bar-b-que at his home on Saturday prior to the AAA meeting in Chicago. Executive Committee and Advisory Board members are invited.
 - Donna asked all Executive Committee members to give some thought to putting together a job description for their positions and to have a one paragraph job description ready for our next meeting in Chicago. She pointed out that this would be very helpful when there is a change in the persons holding the various offices.
 - Donna concluded her President's report by asking John Ahern, as Vice-President for Administration, to list action items at the conclusion of the minutes for future Executive Committee meetings.

Vice-President: Finance Alfred Wagenhofer next presented the 2006 audited financial statements along with the 2007 budget:

- The Executive Committee discussed the merits of switching from the cash basis of accounting to an accrual basis. No change will be made.
- The 2007 budget is prepared on a cash receipts and disbursements basis. Alfred noted, that while it appears that IAAER has excess funds, most of these will be expended to meet the commitments of the KPMG Research Grants. This is why we now separate restricted from non-restricted funds. Alfred then walked through the 2006 audited financial statements and the 2007 budget explaining the purposes behind each of the various items.

Vice-President: Administration John Ahern then gave his report:

He reported that IAAER had grown extensively in recent years and thus needs additional administrative support in order to run smoothly. Since taking office he has relied on two members of DePaul's administrative staff to support IAAER. Brian Maj was been working on some of the more technical areas including the membership data base and invoicing members for their dues. Sarah Musto has become involved in communications, logistics, and member correspondence. He requested that the Executive Committee approve a stipend to be paid to Brian and Sarah for their work for the year 2007. Street noted the significance of building administrative support as IAAER grows and sponsors more activities. She also shared that she had recommended that IAAER "purchase" some staff time from DePaul. This request was approved.

Tax returns for 2006 were distributed as was the Form 8739 Support Schedule for the Advance Ruling Period. John stated that the IRS had acknowledged receipt of the Form

President Street and other discussed upcoming conferences including the:

- AMIS Conference in Bucharest in June 2007. Donna Street will give a Keynote Address and Recep Pekdemir will participate in an Education Panel. Later in the session Clair Minchington (Education Director of the ACCA) also agreed to be part of the Education Panel.
- Paris & London in September, 2007. IAAER is collaborating with Peter Walton as he plans the EUFIN conference in Paris. IAAER is sponsoring two plenary sessions featuring Mary Barth and Katherine Schipper. Peter will also invite the five IAAER / KPMG Liability and Equity Distinction teams to present their preliminary findings. The day following the EUFIN conference we will have the first deliverable for the IAAER / KPMG grant program at the ICAEW's Chartered Accountants Hall in London. Donna Street will attend as will Serge Evraert and Recep Pekdemir. As grant receipants Agnes Cheng and Gunther Gebhardt will also attend.
- Joint Conference in Mexico City in September, 2007. The Call For Papers is out. The Executive Committee will meet at this Conference on Wednesday afternoon, September 26 and will also have a dinner meeting after the opening reception. A request was made from the conference organizers that the Executive Committee allocate IAAER funds to help underwrite this Conference. Following considerable discussion the Committee agreed that it is not our policy to underwrite conferences as we believe our conferences should break even. However, we understand that we need to be ready to assist with any deficits our Institutional Members and other co-sponsors may face. Therefore, instead the EC approved an amount of up to \$3,000 to cover a possible deficit. We also agreed to cover the registration fees of all attending Executive Committee members and the Executive Committee dinner.
- ICAEW Better Markets Conference London—December, 2007. This Conference is by invitation. For the past few years, a few members of the IAAER Executive Committee have served on the ICAEW's planning committee (Street, Hoogendoorn, and Wagenhofer). In return, we are guaranteed several slots at the conference. Executive Committee members wishing to attend must request invitations. Recep Pekdemir, Alfred Wagenhofer, Gunther Gebhart and Donna Street will all request invitations. The conference focus will be Intangibles and next year's will be Pensions. IAAER Executive Committee members will continue to serve on the 2008 planning committee.
- Joint meeting with the AAA International Accounting Section in San Diego, February 2008. The call for papers is available on the IAAER website. Donna Street is representing IAAER on the program planning committee and will be in charge of panels. The IFAC IAESB will be holding a meeting in San Diego immediately before or after the conference and will conduct one plenary session. A breakout session will follow for those interested in learning more about the IAESB. Gary Sundem will assist with the panel.

- AFAANZ Sydney, 2008. On behalf of AFAANZ, Jenny Stewart reported that a professional conference organizer has been retained. The conference will be held at the Sydney Hilton which has excellent meeting space. Bryan Howieson described the preliminary conference schedule. Bryan reported that IAAER has been asked to provide a Plenary speaker and also to organize an Education Panel. A conference call was planned to include Donna Street, Bryan Howieson and Niamh Brennan.
- Possible conference in San Paulo in either 2009 or 2010. Donna Street will meet with our new VP at Large in Brazil this July to discuss this possibility. She will be in Brazil representing IAAER at the USP Congress.

Gary Sundem presented a brief report on his activities as Vice-President Education. He distributed a draft of a Call For Proposals which was being discussed with representatives of ACCA. This program is designed to support scholarly research directed at the IAESB's standard setting activities. He discussed the program objectives, potential funding and some illustrative research questions. Clare Minchington and Caroline Oades expressed ACCA's interest in the project. Both would be joining us later to further discuss this and other collaborations. Donna and Gary would also follow up with Clare and Caroline later during the EAA conference to develop details.

Lee Radebaugh presented a report on his activities as Vice-President Communications.

The website has been updated to report on the status of the IAAER / KPMG Research Grants. Lee asked Executive Committee members to send him a picture and biography (brief) for the website. Lee reported that he will be adding a photo gallery from the Istanbul Conference. Lee and other EC members then discussed the need to grow and update the website. EC members were asked to look at the website for possible suggestions.

It was decided that the target publication date for Cosmos would be two months following the Annual Meeting of the EAA and the AAA. This will enable timely reporting following key Executive Committee meetings.

The Executive Committee discussed some ideas about a membership drive for IAAER. Dick Wilson suggested that we should have a document available which would provide reasons as to why is would be advantageous to join IAAER. Executive Committee members were asked to think of ways to promote university memberships.

Dick Wilson suggested that it might be worthwhile to recognize the contributions of outstanding reviewers for ACCOUNTING EDUCATION: AN INTERNATIONAL JOURNAL. He pointed out that such recognition of reviewers would go a long way to enhance the quality of the journal. The Executive Committee then approved awarding 3 plaques for outstanding reviewers on an annual basis. The nine Associate Editors of the journal would choose the winners.

A brief discussion ensued about changing the name of IAAER. It was suggested that the Executive Committee consult with former president Sid Gray as this topic had been on the agenda some time in the past.

A suggestion was made to include the term "Research" in the title of the next World Congress.

The Executive Committee agreed to a series of "Action Items" which needed to be addressed shortly:

- 1. Agnes Cheng will be charged with putting together a brochure explaining the benefits of University Membership in IAAER.
- 2. John Ahern & Bel Needles will complete the invoicing of KPMG for the annual Diversity Grant.
- 3. John Ahern will make sure that dues statements are sent to Institutional Members.
- 4. Donna Street will report to Salvador regarding our funding decision for the conference in Mexico City.
- 5. Dick Wilson will put together a proposed set of criteria relating to the IAAER's recognition of outstanding Accounting Education reviewers
- 6. Each Executive Committee member will prepare a one paragraph job description of their office one week prior to the meeting in August.
- 7. Sarah Musto of DePaul will send each Executive Committee member the contact information of all EC members.
- 8. Martin Hoogendoorn will prepare a listing of research issues surrounding the topic of leasing for a possible conference with ACCA.
- 9. Gary Sundem and Donna Street will meet with ACCA to further develop the education research grant program.
- 10. Lee Radebaugh will continue to explore ways to enhance the IAAER website. This will be a major topic at the August meeting.

Prior to the close of the meeting, the Executive Committee was joined by Clare Minchington (Director of Education) and Caroline Oades (Director of Research) of the ACCA. We agreed to go forward with planning a joint grant program to fund research to inform the decisions of the IAESB. Sundem and Street will work with ACCA on this activity. It will follow the model of the IAAER / KPMG grant program. A funding request will be submitted to the ACCA Research Committee later this year.

We agreed to go forward with planning a co-sponsored research conference in London. The topic will likely be leases and lease accounting.

The meeting was adjourned by Street. Guests from the ACCA and members of our Advisory Council then joined the Executive Committee for lunch.



Research dealing with the 'how', 'why' and 'should' interface questions has limited exposure in the research journals. The problems of linkage and closure between academic education and professional training have currency, given the present pressures from students and employers to move accounting preparation to a more efficient, economic and practical basis. Expectations of academics, students, employers and professional bodies struggle for alignment as current university and professional employment conditions generate new pressures for changing the academic and professional pathways for educational development.

Papers are sought on any aspect of interface topics between academic education and professional training in accounting. The following list of suggested topics is indicative but not intended to be exhaustive:

- Historical analysis of pathways
- Critical evaluation of interfaces
- Models for successful interface
- Drivers for changes in interface/linkages
- Convergence/divergence accounting education and accounting work
- Failure in academic and professional provision of accounting education
- Studies of current academic and professional accounting education evaluative, critical, analytical
- Mediating forces for change in education and training
- Significance of expectation gaps
- Jurisdictional disputes between Academic Education and Professional Training
