- To ensure that all material provided to the Publisher is complete with all illustrations and tabular matter, final permissions and assignments of copyright and is in accordance with the guidelines given in the Instructions for Authors, and to ensure the following:
  - that copy is original and has not been published elsewhere;
  - that copy is not defamatory or otherwise unlawful;
  - that copy is available for publication in the Journal free of charge

• To provide the material to the Publisher in accordance with the Production Schedule.

#### Qualities sought and Selection criteria

The incoming Editor will be expected to bring the following characteristics to the position:

#### Experience

- Wide interests and knowledge across a range of research in the fields of Financial Management and Accounting
- A good record of personal research initiative, expertise, and performance
- Some successful editorial experiences
- Astute editorial judgment and, ideally, a track record in the evaluation of research publication

#### Vision

- Endorsement of the broad remit and goals laid out in the Journal's editorial statement and Aims & Scope
- Commitment to the Journal, maintaining a good level of scholarly rigor in the field
- A willingness to contribute ideas for editorial initiatives and developments such as new themed issues, genres, and formats
- Determination to pursue equity and diversity on all dimensions

### Proficiency

- High level of efficiency, with excellent time management and administrative skills, and the ability to work to continual deadlines
- High level of written language skills and commitment to the publication of clearly presented and accessible scholarship
- Awareness of changes in the research publishing environment and a flexible and collaborative working style

- Ability to maintain ongoing relationships with an extensive constituency of scholars, in person and electronically, including the Journal's Editor-in-Chief
