CHALMERS provides an update about the nominations for the EC and confirmed nominations for six out of eight positions for the VPs-at-large, with the possibility of filling the remaining available roles throughout the year. She thanks everyone who supported the process. CHALMERS notes that nominees not selected by the Committee might be contacted in the future for various opportunities.

GORDON also suggests that it would be useful to revisit the nomination process and establish clearer guidelines. This could include creating a standardized nomination template, without requiring changes to the constitution, but ensuring procedural clarity. Finally, the Board of Advisors is seeking additional members. IAAER could evaluate whether more members are needed and identify suitable candidates.

GORDON agrees that fine tuning the nomination process is a good idea.

STREET presents the highlights from the DREA report, which has been made available to the EC members before the meeting. She draws particular attention to the SAAA IAAER joint meeting in South Africa in June, which offers many opportunities to engage. She also stresses

HODDER discusses the finances and presents the main issues, assessing the financial situation as positive overall.

KRASODOMSKA has nothing to report.

ALBU expresses gratitude for two years of service as Vice President for Conferences and thanks Betsy and Donna for their support. He mentions the creation of a file in the VP Conferences Dropbox folder to provide updates on new conferences and a schedule, as well as to share some ideas. He also refers to the next possible events with IAAER in Prague and Bucharest.

BIRT provides an update on the "Attractiveness of the Profession" project, which is part of the IFAC IPAE Innovation Group. BIRT represents IAAER on the Innovation group and is co-Chairing the effort to complete the survey. The project involves developing a survey and questions and reaching a broad group of stakeholders, including high school teachers, high school employees, and professional associations from various jurisdictions. Surveys will be distributed in January or February, alongside interviews with various groups. Once final input is collected, BIRT will report back on the outcomes.

MACHADO reflected on gaining deeper insights from the practice community and highlighted three key areas: (1) ACCA Research Plan for 2025: (2) ACCA Membership Events: (3) Leveraging ACCA Global Forums, including Audit and Assurance; Corporate Reporting; Ethics; and Education. The ACCA Education Forum is identified as especially useful for the ACCA-IAAER collaboration. Also, in the past IAAER had a representative on the Education Forum.

JANSE VEN RENSBURG shares slides presenting the most relevant information regarding the promotion of IAAER activities on LinkedIn. There is a need for more content on various topics hosted by member organizations. GORDON moves on to discuss the issues related to the IAAER Council.

ADIKHARI suggests that the Council should be approached when the EC is seeking advice on particular issues, and it can identify 2-3 critical issues for the Council to address. Membership is one key area, as the goal is to drive membership growth. The VP Membership or the President could take charge of the discussion and drive the strategy. The Council can be tasked with working on and developing a plan. In terms of IAAER conferences, ADIKHARI notes that there is potential to leverage events like in India. The Council could use these events to drive key agenda items.

STREET added that several universities are making substantial investments in IAAER and suggested that the EC could consider allowing universities to nominate representatives to the Council. ADIKHARI and KRASODOMSKA volunteered to assist STREET in proposing a formal plan to engage universities and offer them a place on the Council. RANKIN proposes to introduce an overlapping period of service on the Council so there is no situation in which the whole Council is being replaced with new members at the same time.
